

ANZ Twilight at Taronga Ticket Upgrade Promotion

Terms and Conditions

1. Information on how to enter the promotion forms part of these terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The promotion commences at 9.00am (AEDT) on 3 January and closes at 11.59pm (AEDT) on 2 March 2017 (“**Promotional Period**”).
3. Entry is open to New South Wales residents who are over the age of 18 and who have already purchased tickets to a concert (outlined in condition 7) that makes up the Twilight at Taronga Concert Series (“**Eligible Entrants**”). The Promoter reserves the right to request that the winners provide proof of identification, age and Australian residency prior to receiving a prize. Proof of identification, age, and residency considered suitable for verification is at the discretion of the Promoter. The Promoter reserves the right to validate and check the authenticity of any prize claim or entry before awarding a prize.
4. To enter the promotion, participants must during the Promotional Period complete the entry form on the ANZ page of Twilight at Taronga Concert Series (www.twilightattaronga.org.au), complete all entry details requirements including nominating the concert and number of tickets they have purchased tickets for, and be available to accept the prize as stated if they are a winner (on the event date included in condition 7 of these Terms & Conditions). All eligible entries will receive one entry into the applicable draw. One entry per person is permitted per concert (as listed in clause 7)
5. The Promoter is not responsible for any problem or technical malfunction of any communications network or any late, lost, incorrectly submitted, delayed, ineligible, incomplete, corrupted or misdirected entry whether due to error, transmission interruption or otherwise.
6. Entry details will be used solely for the purposes of this competition and will then be destroyed by ANZ unless an entrant has indicated that they allow ANZ to contact them and provide further information regarding ANZ’s sponsorship of the Taronga Zoo and the Twilight at Taronga Concert Series

8. The draws will take place weekly at 2.00pm (AEDT) at the offices of Mike Da Silva and Associates (Aust) Pty Ltd (ABN 50 003 894 022) ('MDSA') at 15 Grosvenor Street, Neutral Bay NSW 2089. The draws will be conducted by MDSA, and the eligible entries drawn in each draw will receive the applicable prize. If an entrant drawn is unable to accept the prize as stated, including on the date indicated, they will be considered ineligible and another entrant/s will be drawn until all prizes can be awarded.
